Perceptions of the EU in Vietnam

According to a public opinion survey carried out by "The EU through the Eyes of Asia" research team, the EU ranks 5th in a list of most important partners for Vietnam both in terms of the present and future partnership. The survey sees the EU rank behind China, Japan, USA and the rest of Asia, yet according to the Vietnamese Ministry of Planning & Investment the EU's cumulated implemented Foreign Direct Investment (FDI) till 2008 (approximately US\$ 7 billion) confirms the EU as the second largest investor in Vietnam after Japan.

"Misperception or ill-informed views of the European Union's global role puts the EU at risk of being overlooked or undervalued by third countries with [which] the EU is a significant partner. Similarly, low awareness of the EU expose[s] third countries, like Indonesia, to the risk of slipping under the EU's radar," according to **Prof Martin Holland**, Jean Monnet Chair ad personam, National Centre for Research on Europe of the University of Canterbury.

In 2006, the Asia-Europe Foundation (ASEF) and the National Centre for Research on Europe (NCRE) in reaction to this existing knowledge gap initiated the "EU through the Eyes of Asia" project to address "How the EU was perceived in Asia". The project's latest publication, "The EU through the Eyes if Asia Volume II: New Cases, New Findings", was recently launched at Vietnam National University in Hanoi, Vietnam. The event was organised in partnership by the Asia Europe Foundation, the Delegation of the European Commission to Vietnam, and the University for Social Sciences and Humanities, Vietnam National University.

Mr Willy Vandenberghe, First Counsellor/Head of Cooperation Section, Delegation of the European Union to Vietnam, said, "This publication is very timely, just after the entry into force of the Lisbon Treaty, which will pave the way for better coherence in and visibility of the EU's external action, through the nomination of a High Representative for External Relations and the forthcoming establishment of the European External Action Service."

"For Vietnam, the European Union is an entity with familiarity and exoticism, proximity and distance, and tangible existence and invisibility. This could be explained by various historical, cultural, political, economic factors to even personal connections. The Europeans were the first to romanise the script of the Vietnamese which is now used as the national official writing system", noted **Prof Vu Duc Nghieu**, Vice Rector of the University of Social Sciences and Humanities of VNU-Hanoi, adding, "The relations between Vietnam and member states of the EU have undergone different ups and downs, ebbs and flows, throughout the colonial period to the Cold War, and the recent process of globalisation and regionalisation. For those reasons, the EU has been reflected in the lenses of the Vietnamese in a diversity of forms and shapes."

This unprecedented comparative study looks at the attitudes and citizens' perceptions of the EU in Asia, and, to date, the project has been undertaken in 12 research sites throughout Asia. The Asia wide research project is a major academic collaboration to measure media, public and elite perceptions of the EU in the Asian countries of the Asia Europe Meeting (ASEM)*. The latest findings of this project are expressed in this new publication which provides detailed empirical

insights into EU's visibility in the public discourses of 3 Southeast Asian countries — the Philippines, Indonesia and Vietnam. The data and analyses in this work cover the period between 2008 and the first half of 2009, and compares the findings with those included in Volume I (published in 2007), which examined the perceptions of the EU in China, Japan, Singapore, South Korea, and Thailand. The data collected through this project is of direct relevance to policy-makers and opinion leaders across Asia and Europe, providing essential recommendations to the EU, Asian governments, the media and those managing relations between the two regions.

In December, 1993, VNU was reorganised on the basis of amalgamating the University of Hanoi, Foreign Language Teachers' Traning College (established in 1967) and other leading universities in Hanoi.

VNU is entrusted with the task of producing qualified human resources for the industrialisation and modernisation of the country. VNU holds a special position in the system of tertiary education in Vietnam, operating according to a special regulation promulgated by the Prime Minister.
