The Asia-Europe Foundation (ASEF) together with the Raoul Wallenberg Institute, the French Ministry of Foreign Affairs and the Philippine Department of Foreign Affairs will organise the '13<sup>th</sup> Informal ASEM<sup>1</sup> Seminar on Human Rights: Human Rights and the Environment' on 21-23 October 2013 in Copenhagen, Denmark.

"The 13<sup>th</sup> Seminar will explore the protection and promotion of human rights in relation to the environment and climate change within the ASEM framework," highlighted Mr Karsten WARNECKE, Deputy Executive Director of the Asia-Europe Foundation (ASEF).

Ms Ida AUKEN, the Danish Minister of the Environment, and Dr John KNOX, the United Nations Independent Expert on Human Rights and the Environment, will be among the keynote speakers at this event.

Hosted by the Danish Ministry of Foreign Affairs and the Danish Institute for Human Rights, the event will welcome more than 120 participants including official representatives from ASEM countries as well as civil society members. Participants will discuss key concerns of human rights and environmental protection and develop policy recommendations for Asian and European decision-makers.

The closed-door working group discussions during the seminar will focus on: the Interaction between Sustainable Development, Environment and Human Rights; Access to Information, Participatory Rights and Access to Justice; Actors, Institutions and Governance; and Climate Change and Human Rights Implications.

Mr Villy SØVNDAL, the Danish Minister for Foreign Affairs, will address the participants on the final day of the seminar.

**About the Informal ASEM Seminar on Human Rights**

The Informal ASEM Seminar on Human Rights Series was initiated by France and Sweden at the 1<sup>st</sup> ASEM Foreign Ministers' Meeting in 1997. In 2011, the Department of Foreign Affairs of the Philippines joined the Series as an organiser. The initiative promotes mutual understanding and co-operation between Asia and Europe in the area of political dialogue, particularly on human rights issues. ASEF has been the secretariat for the Seminar Series since 2000. Participation in the Seminar is by invitation only.
